**The St. Louis Health Equipment Lending Program (STLHELP) increased its impact in 2022. The number of people served more than doubled from 2019 to 2023, from 619 to 1664.**

**Likewise, we diverted 54.87 tons of home medical equipment away from St. Louis area landfills in 2022, up from 20.06 in 2019. STLHELP increased access to free home medical equipment by adding online access in 2022. Now anyone can request HELP anytime. This approach enables people to request help not only by telephone, but even from the internet, including hand-held devices.**

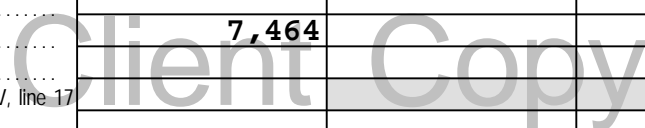
